Introduction

The year 2002 was another successful leg in the build-up of the ETC. The summer semester was opened in March with a lecture by the President of the European Court of Human Rights in Strasbourg, Dr. Luzius Wildhaber, organized in cooperation with the Administrative academy of Styria. In the beautiful venue of the Mozarthof (in Schuberstraße 29, 8010 Graz) the ETC was able to welcome a growing number of regular as well as occasional visitors during its interesting lectures, panel discussions and seminars.

Concerning the **Training Activities**, the panel discussions of the "Dialogue of Civilizations", dealing with Buddhism and Islam and their connection to human rights, have to be emphasized. The accentuation on South-Eastern Europe was highlighted by the symposium "The Role of Human Rights in Post Conflict Situations in South-Eastern Europe" in June, featuring a number of foreign lecturers. In the scope of "Graz as Human Rights City", a series of lectures dealt with current human rights problems in Graz, which found its extension with the "Hot Topics" of the Graz 2003-project "Culture of Human Rights".

Council's monitoring of two lectures, "The Problem of Medical Care of Detainees" and "The First Three Years of the Human Rights Advisory Council Activities". For the first time, a training seminar "How to Unlearn Prejudices?" was held in cooperation with the Anti-Defamation-League (ADL). A seminar on "Labor and Social Standards in the Era of Globalization" fell under the pillar of the "Economic and Social Rights"-focus. Another focal point of the ETC is the training of teachers. An overall Austrian teacher seminar as well as a series of seminars for teachers, who are active in the field of political education, were arranged in company with the Pedagogic Institute for Styria (PI). Moreover, lectures with students were organized. This way, the European Training and Research Centre for Human Rights and Democracy could live up to its responsibility in the field of human rights education.

In the field of Research, additionally to the continuation of existing projects such as "The Role of Human- and Minority Protection in South-Eastern Europe" ("Institutionalizing Ethnic Diversity") and the project "Human Security and Human Rights Education", two new projects concerning legal indicators and job opportunities for new minorities/migrants were carried out. In consequence of long negotiations the project "Culture of Human Rights", the ETC's contribution to Graz 2003 – Cultural Capital of Europe, started



Another main focus was the Human Rights Advisory presidency in the Human Security Network, the ETC was entrusted by the Ministry of Foreign Affairs with the development and the editing of a manual dealing with Human Rights Education for the **Ministerial meeting in Graz in May 2003.**

The ETC could achieve considerable progress in the field of research, although even more could be done in this area. In this regard additional to the ETC a **Research Association** was established in order to strengthen its research activities and to enable donors to give contributions to the ETC free of tax.

With regard to the coordination and supervision of the project "Graz as Human Rights City" the halftime conference in June 2002 highlighted the activities which had already taken place until that point of time. A survey was elaborated by more than 100 people and institutions from Graz and a program of action was presented. Deriving from this program of action, concrete measures shall be taken in the year 2003. In December 2002 the ETC, representing the city of Graz, participated in a conference on "Human Rights in the City" of a network of more than 200 cities and communities in Venice, which all had signed the "European Charter on Human Rights in the City". This conference showed the growing importance of human rights on the local level.

In the field of **Personal Development** Univ.-Prof. Dr. Joseph Marko left the executive board of the

in July 2002. With regard to the Austrian

ETC in April 2002 in order to put more focus on his Competence-Center on South-Eastern Europe. In autumn Dr. Gerd Oberleitner, the executive secretary of the ETC, left Graz for London taking up a job-offer as lecturer for human rights at the London School of Economics (LSE). The ETC team is much obliged to both of them for their valuable constitutional work. Since then the ETC has been trying to find a new executive secretary, but a suitable person could not be found so far.

The built-up of the **Library**, which is being used by many students and pupils, has been very successful. The ETC provides information on its current activities through its quarterly newsletter, a new occasional paper-series and a permanently updated homepage for an increasing number of interested people.

The ETC, as NGO active in the field of human rights, regards it as an essential duty to offer **Internships** to students. With regards to human rights questions the ETC assists the city of Graz as well as other institutions. Due to the high-level of some of the interns several were invited to participate in projects, which resulted in the expansion of the ETC staff.

Regarding the **Financial Situation**, the ETC was able to balance evenly, although some of the expected contributions, particularly from the



Ministry of Education, did not arrive. Nevertheless,

the financial situation is supposed to improve in the year 2003. Altogether the situation of the ETC can be considered to be consolidated. The basis for further successful activities in spreading the knowledge of human rights and fostering a culture of human rights in Graz, Styria and South Eastern Europe has been laid. A number of co-operations were established, whereby the good cooperation with the University of Graz has to be stressed.

III. Research Projects

Research Project "Institutionalizing Ethnic _ Diversity in (Post-)Conflict Situations: The **Role of Human Rights and Minority Protection** in South-Eastern Europe". This international and interdisciplinary research project, which was completed in December 2002, is one of the winner projects, initiated by the Ministry of Science under the framework of "Promoting Peace and Preventing Violence". After hosting regional workshops in Vukovar, Sarajevo, Ljubljana and Belgrade, a series of case studies and cross cutting studies were presented in order to analyze the "success stories" and "failures" of the region on the local and regional level. In turn, they were compared with the "success stories" from South Tyrol and the Brussels region. With that, a basis for reorientation was offered to international mediators and the local population, primarily to the future political elite. The aim was to forward the democratization process and to promote the consolidation of rule of law in the ethnically divided societies.

"Culture of Human Rights" within the Framework of Graz Culture Capital 2003. Graz is the Culture Capital of Europe in the Year 2003

- and furthermore since 2000 the **first Human Rights City in Europe**. In order to position the Human Rights City Graz as a city of Human Rights Culture, the project "Culture of Human Rights" wants to contribute to the essential debate on human rights during the year 2003. The declaration of Graz as the first European Human Rights City – this was already announced in advance in the speech of the Austrian Foreign Minister before the General Assembly meeting of the United Nations in September 2000 - in the local council session on February 8th 2001 further stressed the importance of the project.

The idea of the project is to establish a relationship of the citizens of Graz to human rights in their hometown. All city-relevant decisions shall be viewed in the light of human rights, which actually should already be part of the decision-making process, to clearly and explicitly stress the influence of human rights on everyday life.



Project "Human Security and Human Rights _ Education"

The Austrian presidency in the Human Security Network in the year 2002/2003 placed further challenges on the ETC. A preliminary study about possible activities in the area of human security and human rights education was elaborated during the presidency for the Ministry of Foreign Affairs. From all proposed measures, the Minister of Foreign Affairs, Dr. Benita Ferrero-Waldner, commissioned the elaboration of a "Graz-Declaration on Human Rights Education" as well as a "Manual on Understanding Human Rights". The ETC launched the assignment in September 2002 and will present the outcome in May 2003. Furthermore, Dr. Gerd Oberleitner composed a study on "Human Security and Human Rights" which was presented at the Conference of the North-South Center in Lisbon (see the Occasional Paper Series on the ETC homepage).

Research Project "Legal Indicators for the Social Inclusion of New Minorities (LISI)". The goal of this EU-financed project, which is carried out in cooperation with EURAC (Bolzano) and AIRE (London), is to develop indicators in order to assess the legal situation of the integration of foreigners. These indicators can help evaluating migration-policies in a broader political context. In the first half of the year 2002 each of the three partners drew up regional reports on the current legal status in Styria, South Tyrol and London. The main findings were summarized in the Report on Common Issues and Best Practices. Under the chief responsibility of the ETC, individual indicators for the main areas of problems were developed in the second half of the year 2002; the outcome of this phase was summed up in the Report on Legal Indicators. After a public discussion and the circulation of the result, the project will come to an end in the year 2003 and its outcome will be published.



FREE-Projekt

The task of the project "Fund for Refugee Employment and Education" was to examine the possibility of implementing a fund, after a model from the Netherlands, which supports asylumseekers and refugees through scholarships and loans inter alia.

This project, financed by the European Refugee-Fund, was coordinated by three international NGOs (WUS/RETAS – Great Britain, UAF – The Netherlands, OCIV – Belgium) and carried out through partner-organizations in fourteen EUcountries, the ETC being the Austrian partner to do the study.

The project phase accomplished in 2002 included the compilation of a feasibility study, the composition of a country-report and the creation of a data-bank, which contains the results of the questionnaires and contacts. Public authorities, educational institutions, NGOs and corporations were asked to fill out the questionnaire. The project phase of 2002 ended in December with a conference in Amsterdam. Additional researchactivities and steps for implementation will follow in 2003.

Activities will be the dispatchment of a questionnaire (based on a representative spot test), one-to-one interviews, case studies as well as a summed up presentation of the legal status and relevant practice.

Next to the question of the feasibility of the concrete model, it was interesting to see, whether

solutions for the existing needs could be found and whether the mobilization of corporations for social concerns already is possible.

IV. Participation in International Study Programs

Coordination of the participation of the Karl-Franzens-University Graz in the European Regional Master Program on Democracy and Human Rights for South-Eastern Europe for 35 Students in Sarajewo/Bologna. Coordination of Cluster V on the implementation of human rights, teaching activities, participation in Board Meetings. In the year 2001/2002 an ETC-colleague participated in this Program. Supervision of the participation of the Karl-Franzens-University Graz in the EU-Master-Program on Human Rights and Democracy in the European Union. For a few years now the EU-Commission has been financing a one-year study program for about 90 students in Venice and other partner universities in the EU member countries. The ETC co-ordinates the participation in this program for the University of Graz, which is one of the 28 partner-universities/institutions. The co-ordination includes the conduction of courses in Venice, the participation in Board Meetings as well as in special lectures, the promotion of the program and the participation in the selection process. From the summer term 2003 on, the ETC will additionally be responsible for the supervision of the "Masterini", who decide to spend the summer term in Graz.

V. Activities for the Project "Graz as a Human Rights City"

At the half-time of the project, on June 28th 2002, an 'Evaluation-Conference' was held in the city hall of Graz. There, the first project phase was brought to an end and the second phase - the so-called action-phase - started with the presentation of an analysis on the human rights situation in Graz and a discussion on the concept of an action-program. This analysis investigated the strengths and shortcomings regarding the implementation of human rights in Graz; the findings shall be used as a basis for the determination of the final goals. The analysis is based on the results of three working aroups, which dealt with political/civil, economic/social and cultural human rights, and elaborates on problem-areas, where the rights of affected people are not protected sufficiently. Thereafter a series of guidelines, on whose basis a program of activities was developed, were created. During the next phase, which will most probably last till autumn 2003, possible short-, middle- and long term improvements, which should already have an impact in the culture-capital-year 2003, shall be launched.

Maintaining the sustainability of the project after 2003 will be up to the city government and the munipal council of Graz which will have to take the necessary measures of implementation.

VI. Network of Human-Rights-Centers in South-Eastern Europe (SEE HRC-Net)

Within the framework of the international coordination of the network, the ETC was involved in a series of activities, particularly in hosting several regional and international human-rights workshops, a two-week summer school on 'Human Rights and Human Wrongs in SEE' in Ohrid, Macedonia, and a three-day workshop about a culture of human rights in Sveti Stefan, Montenegro. Beyond that the ETC monitored three publications of regional research projects - 'Culture of Human Rights in South-Eastern Europe', 'Rights of Students in South-Eastern Europe', 'Human Rights for Non-Lawyers' – which were written in English and local language. Furthermore the ETC participated in a project, which promotes humanrights education, and in the construction of the human rights center at the university of Zagreb.



VII. Library and Publications

In the year 2003 about 90 books were bought for the ETC-library, which means that the current stock has grown to the number of 800 books. The library was used by more and more pupils and students, which were given help and advice in their literature search. The budget is unfortunately not sufficient, particularly regarding the purchase of newspapers.

In the year 2002 again four issues of the ETC Newsletter appeared; whereas one longer article, preferably coming from a member of the ETC-advisory board, was put on the front page.

For a better circulation of the work of the ETC the series Occasional Papers was established. This series, which includes papers from the ETC team or reports from ETC lectures, can be found on the ETC Homepage.

VIII. Public Relations

_ Homepage

After a fundamental reconfiguration in 2001, the homepage of the ETC (<u>http://www.etc-graz.at</u>) was further enlarged. The new category "Publications", which contains in-between reports of research projects and lectures from ETC members, must be emphasized. Another highlight is the category "Current Issues", where materials from ETC lectures, such as on the topic "Human Rights and Anti-terrorist Measures" (hosted together with the Diplomatic Academy) and "3 Years Austrian Human Rights Advisory Council" (with cooperation of the CPT), can be found.

Specifically for the Human Security topic, which was and still is one important ETC research-emphasis, additional homepage was set an up (http://www.etc-graz.at/human-security/). Via this page parts of the communication with the stakeholders from the worldwide Human Security Network, which contribute to the establishment of the Manual "Understanding Human Rights", takes place. The ETC will continue to endeavour its research- and training activities to the broad public through the modern communications technology.

Booklets

on the Human Rights City and about the project "Culture of Human Rights" provide additional information. Further booklets as well as a new folder about the ETC are "under construction".
